Net 30 Days. (After approved credit) 2% interest per month charged on the past due accounts.

Shipping & Handling:

Domestic shipments are F.O.B. City of Industry, California; Union New Jersey; Wood Dale, Illinois; Suwanee, Georgia; Miami, Florida; Plano, Texas, with no shipping & handling allowance. International shipments are F.O.B. City of Industry, California only. Shipments are normally sent freight collect, if customer requests shipment sent prepay and charge, 30% freight surcharge will be added. A \$10.00 surcharge per package is added to Parcel Post and United Parcel Shipments.

Quotation Terms:

Quotations protected for 30 days from date of quotation. If an order is received within this period, the material must be released for shipment within 60 days of date of order, otherwise prices will be those in effect at time of shipment.

Returned Goods:

A returned goods authorization is required for all returns. No material may be returned without written authorization. Transportation charges must be prepaid. Any cost associated with restoring product to saleable condition will be deducted from credit. A 35% restocking charge may apply. Credit will be issued to apply against future purchases only.

Special Orders:

Items other than standard, or those specially produced, cannot be cancelled or returned for credit.

Claims:

Any shortage or error in shipment must be reported within 30 days. Damaged or lost materials are the responsibility of the purchaser, and should be reported to the carrier at once.

The minimum order value is \$100 NET. In the event an order is received under that stated minimum order value, a \$25.00 "minimum invoice service charge" will be applied to the order but at no time will the minimum order exceed \$100.00 NET before shipping, handling and taxes. All service charges are non-refundable.

This price guide cancels all previous price guides and is subject to change at any time without notice. Possession of this price guide does not constitute an offer to sell.
